**Emancipation Exposition in Manhattan, Monument to Race Advancement.**

**EXHIBITS TRACE EACH EPOCH.**

**Half of Great Opening Through White People—Industrial Pace.**

In celebration of the fifty years of progress of the race since Lincoln freed the negro in 1863, every phase of present-day negro activity is now being exhibited at the "Fiftieth Anniversary of the National Emancipation Exposition," which has been planned by the National Negro Laborers' Union, and the exhibits have been arranged in such a manner as to give a general history.

More than 100 persons were present at the opening of the exposition yesterday, and more than had been expected. Visitors from the white race are expected to be numerous during the days that the exposition continues, as there has never been given any opportunity to see so complete an illustration of the history of the colored race.

The exposition is to be open daily, both afternoon and evening, from October 23, and there are to be features every day. The chief of these is the "Fiftieth Anniversary of the National Emancipation Exposition," which was written by W. B. DuBois, an eminent colored man, and is the presentation of the history of the colored race since the signing of the Emancipation Proclamation.
